## We Respect Your Privacy.

We respect and protect the privacy of our website visitors.

#### Kinds of Information Collected

There are two kinds of information that can be obtained about our website visitors:

- 1. Aggregate Information
- 2. Personally Identifiable Information

We do not automatically obtain any Personally Identifiable Information. We collect Personally Identifiable Information (such as your name, address, phone number, and e-mail address) only when you specifically and knowingly provide this information to us via email or through a Web form.

### **Security of Collected Information**

Any Personally Identifiable Information you provide to us is kept in secure files. Access to these files is limited to only authorized individuals within this company who have the need to know. We continuously make all reasonable efforts to protect your information from theft, misuse and alteration.

### Disclosure

We do not disclose your personal data to any other organizations unless required to do so in compliance with any valid legal process such as a search warrant, subpoena, statute, or court order.

#### Access to Your Data

#### **Use of Cookies**

We reserve the right to use cookies as we see fit in order to limit multiple responses and registrations on a customer survey. We also may use cookies to limit the number of times a promotional page will appear.

We never use cookies to retrieve information from your computer that was not originally sent by us to you in a cookie. We do not use information transferred through cookies for any promotional or marketing purposes.

As we do not run advertising on our website from third parties, you will not receive a cookie from any third party advertisers by visiting our website.

Most browsers are initially set to accept cookies. If you'd prefer not to, you can set your browser to refuse cookies or to alert you when cookies are being sent.
